Company Overview:

MIACH Orthopaedics, Inc., a commercial stage, privately held company located in Westborough, Massachusetts, is dedicated to developing bio-engineered surgical implants for connective tissue restoration. The company's initial focus is on ACL injuries. The company introduced the BEAR® (Bridge-Enhanced® ACL Restoration) Implant for commercial use in October 2021. The BEAR Implant is the first technology to clinically demonstrate that it helps regenerate a patient's own ACL tissue. The current standard of care for treating ACL ruptures is reconstruction, which replaces the native ACL with a graft harvested from the patient or from a deceased donor.

Position Overview:

Reporting to the VP Clinical, Regulatory and Compliance, the Director of Medical Education is responsible for developing a best-in-class medical education strategy for healthcare professionals that aligns with and supports company goals and advances market access. The individual is responsible for developing, facilitating, and implementing comprehensive regional and local programs that include, but not limited to, in-person, digital and virtual programs. In addition, he/she is responsible for assessing the effectiveness and impact of the programs on the surgical practice behavior of the HCPs. The Director of Medical Education will be the primary contact and coordinate with key societies and associations to ensure the company is well represented at conferences and symposiums

 - The plan should include detailed project steps, timelines, and budgets, as well as feedback mechanisms to evaluate effectiveness and business impact

- Design and facilitate specific medical education programs for HCPs that recognize and align with where an HCP is on their learning pathway from awareness to adoption
- Assess and implement educational technologies, platforms, and tools to facilitate the best-in-class, most cost-effective medical education experience for HCPs

 - Working with clinical and sales, ensure content and agendas for the programs align with the business strategy, create awareness of the unique benefits of the BEAR Implant, and position the BEAR Implant to become the standard of care in the future
 - Identify key regional and national societies that the company can establish medical education partnerships; collaborate with the scientific societies to ensure Miach's medical education programs are well represented at key regional and national conferences and symposiums
 - Facilitate and oversee all medical education event activities
 - Develop metrics, analyze results, and identify improvements in the content, formats, and delivery of Miach's medical education programs
 - Provide reports to management as needed as well as recommendations for continued improvements to the programs
 - Monitor educational activities to ensure compliance with CMS and AdvaMed guidelines
 - Manage medical education expenses effectively and within budget
